



FredVault™ Partnership Agreement

1. Purpose

FredVault™ agrees to provide access to its proprietary casket vault protection systems to the Partner for resale, bundling, or co-branded distribution.

2. Scope of Partnership

The Partner may:

- Resell FredVault™ products to clients.
- Offer FredVault™ as a value-added benefit in funeral or insurance packages.
- Participate in co-branded marketing campaigns.
- Receive training and support for installation (if applicable).

3. Commission Structure

- Partner earns **10% commission** per vault sold.
- Retail price per vault: **R25,000**.
- Commission: **R2,500 per unit**, paid monthly or per transaction.

4. Branding & Marketing

- FredVault™ grants permission to use its trademarked brand in co-branded materials.
- All marketing must maintain brand integrity and be approved by FredVault™ prior to public release.

5. Intellectual Property

FredVault™ retains full ownership of its designs, trademarks, and product specifications. Partner may not replicate, reverse-engineer, or modify vault systems.

6. Territory

This agreement applies to sales and services within **South Africa and neighboring countries** unless otherwise agreed in writing.

7. Term & Termination

- This agreement is valid for **12 months**, renewable annually.
- Either party may terminate with **30 days' written notice**.
- Outstanding commissions will be paid upon termination.

8. Liability

FredVault™ provides engineered products tested for durability and environmental resistance. However, FredVault™ is not liable for damages arising from improper installation by untrained personnel.

9. Confidentiality

Both parties agree to keep pricing, client data, and strategic plans confidential.

10. Dispute Resolution

Any disputes will be resolved through **mediation in Durban, South Africa**, before pursuing legal action.

11. Non-Disclosure Agreement (NDA)

Both parties agree to maintain strict confidentiality regarding all proprietary information, trade secrets, client data, and business strategies disclosed during the term of this Agreement. Neither party shall disclose such information to any third party without prior written consent, except as required by law. This obligation shall survive termination of this Agreement for a period of 3 years.
